Referral Agreement and Web Site Authorization

Broker, Buyers, Exchangers and other Brokers acknowledge and agree that RExInet has merely introduced Buyers, Exchangers and other Brokers to the Property and does not represent Broker, Buyers, Exchangers and other Brokers in any transaction. This agreement may be terminated by either party at any time via Letter, FAX or Email or upon Brokers listing termination. If RExInet decides to represent a Buyer, then a Co-Op agreement shall be submitted for Brokers acceptance. Any referred party shall remain in force for a period of 5 years from termination of this agreement.

- 1. As compensation for RExInet's referral, Broker agrees to pay RExInet 25% of the commissions received.

 (a) referral fees are also due if Buyer or Exchangers purchase or exchange another property through Broker,
- 2. Compensation is due upon recording of deed or other evidence of transfer involving the prospective Buyer Exchangers and other Brokers.
- 3. This agreement will serve as instruction to the closing office or escrow company to pay the above compensation to Charles Jamgotchian.
- 4. RExInet hereby agrees not to participate in, or conduct, any negotiations between the Broker and prospective Buyers, Exchangers and other Brokers.
- 5. It is understood that RExInet may refer the Buyers, Exchangers and other Brokers to more than one Broker.
- 6. RExInet assumes no liability as to the conditions of any properties shown to Buyers, Exchangers and other Brokers and is not a party to any transaction between the Broker, Buyers, Exchangers and other Brokers.
- 7. Nature of Relationship: Nothing herein shall be construed to place the parties in a relationship of partners, joint venturers or principal and agent, and neither party shall have the power to obligate or bind the other in any manner whatsoever.
- 8. Any legal cost incurred by RExInet to collect the compensation due, shall be paid by the Broker.
- 9. Venue: Any legal proceeding concerning the validity, interpretation or performance of any of the terms or conditions of this agreement or the rights or obligations of the parties shall be instituted and prosecuted in Fresno County, California, United States of America
